After Care Program 2018-2019 School Year

After School Care at Saints Philip & James School offers a variety of activities for students. Activities are supervised by employees of the school. Students have the opportunity to change into play clothes, finish homework, have playtime inside or outside, depending on the weather, and enjoy a home-packed snack.

After Care Procedures:

1. Our program operates from the first full day of school until the last day of school in June. Hours are from dismissal until 6:00pm. A late fee of \$11 per hour will be charged after 6:00pm.
2. If school is closed for the day, there will be no After Care program.
3. If you choose to have your child participate in after school activities, notify the school in writing. We need an authorized person (listed on Emergency Form) to sign the child out by 6:00pm.
4. Payment are made through FACTS.
5. School rules as stated in the SSPJ Student/Parent Handbook will apply to our After Care Program, including the Acceptable Use of Technology Agreement.
6. Children will only be released to a parent or one of the emergency names on the emergency form. A note is required for any changes.
7. A scheduled homework period will be provided on most days. However, it is the responsibility of the parent to ensure that all homework is completed.
8. You are responsible to provide a daily snack for your child (2 snacks for early dismissal days).
9. Parent(s)/Legal Guardian(s) give SSPJ After Care permission to contact the persons listed on the Student Emergency Information form in an emergency situation when Parent/Legal Guardian is not available. In Parent(s)/Legal Guardian(s)' absence, the people listed are authorized to make decisions concerning the child(ren). After Care requires a note or phone call if someone different is coming to pick up the child(ren). Any court documents regarding custody or visitation arrangements should be presented to the principal. While child(ren) is(are) in After Care, should an emergency occur, every effort will be made to contact the Parent(s)/Legal Guardian(s). If all efforts fail, Parent(s)/Legal Guardian(s) consent to any medical treatment deemed necessary by competent medical personnel to save the life or preserve the health of the child(ren).

After Care Fees:

1. A \$40 registration fee per family, per year will be assessed after 5 days in the After Care Program, for each child enrolled in After Care.
2. The fees for After Care are billed at \$7.25 per hour, beginning at 3:00 p.m.
3. Sibling discount is 10%.
4. If your child remains in aftercare beyond 6:00 pm you will be charged \$11.00 per hour
5. You will be billed on a weekly basis through the FACTS system with payment due upon receipt.
6. We reserve the right to restrict the aftercare program use, should your account become delinquent.
